WHAT IS THE STUDENT PROJECT GRANT?

Nebraska Farm Bureau will provide four (4) grants of up to \$1,000 each spring. The purpose of the award is to provide funds for students to begin or expand their 4-H or FFA projects. There is no limit to the scale of the project – students are awarded money based on their budget and goals for the project. Their personal statement, financial need, advisor statement, and project summary are also taken into consideration.

Applicants must hold a current Nebraska Farm Bureau student membership. Students ages 16-23 can join Nebraska Farm Bureau and enjoy the benefits of being a member at a discounted rate. To join Nebraska Farm Bureau, visit www.nefb.org.

WHAT ARE THE CRITERIA FOR SELECTION?

Applications will be evaluated by a panel of judges (Nebraska Farm Bureau members and/or staff). The criteria for selection will be based on the completeness of the application in each area:

- Project Summary
- Budget and Goals
- Financial Need
- Personal & Advisor Statements
